

INTRODUCTION

The Safe, Accountable, Flexible and Efficient Transportation Act: A Legacy for Users (SAFETEA-LU) was the funding and authorization bill for the federal surface transportation program from FFY (Federal Fiscal Year) 2004 to FFY 2012. It was recently replaced with Moving Ahead for Progress in the 21st Century Act (MAP-21).

The Michiana Area Council of Governments (MACOG) is the designated Metropolitan Planning Organization (MPO) for the South Bend and Elkhart-Goshen Urbanized Areas. As an MPO, MACOG is responsible for carrying out the transportation planning process in the federally designated urban areas of Elkhart and St. Joseph Counties. It also fulfills the role of Rural Transportation Planning Organization (RTPO), supporting rural planning activities in Kosciusko and Marshall Counties.

As the MPO, MACOG has tracked all of the funds obligated to transportation projects within the four-county region since the beginning of SAFETEA-LU. This recap summarizes the \$172.5 million in federal funds that was obligated in the MACOG region from October 1, 2004 to September 30, 2012, including a breakdown by county.



An obligation is the Federal government's legal commitment to pay the Federal share of a project's cost. Projects for which funds have been obligated are not necessarily initiated or completed in the program year, and the amount of the obligation will not necessarily equal the total cost of the project. For Federal Highway Administration (FHWA) projects, obligation occurs when a project agreement is executed and the State/grantee requests that the funds be obligated.

SAFETEA-LU FUNDING CATEGORIES

SAFETEA-LU continued the core highway funding categories established in previous transportation legislation, such as Surface Transportation Program (STP), and added one new funding category, Highway Safety Improvement Program (HSIP). After SAFETEA-LU was signed into law, the federal funds were allocated to the States and MPOs.

In Indiana, federal highway funds are allocated based on the Local Sharing Agreement. This agreement outlines the category of funds and the percentage of those funds that are available to the State or Local Public Agencies (LPA). The traditional split of federal funds is 75% of the funds are allocated to the State and 25% are allocated to LPAs. The Sharing Agreement balances the various highway funding categories adjusting the balance to achieve the split. A narrative outlining the funding rules is discussed and reviewed annually at a meeting organized by the Indiana Department of Transportation (INDOT) in cooperation with representatives of the MPOs, Indiana Association of Cities and Towns (IACT), Association of Indiana Counties (AIC), Local Technical Assistance Program (LTAP) and Indiana Association of County Commissioners (IACC). Funds are apportioned based on the Sharing Agreement formula, which has been developed cooperatively with the state's MPOs, IACT, IAC, and other interested Local Public Agency partners.

As previously mentioned, various federal funding categories could have been obligated throughout the life of SAFETEA-LU. The Group I Surface Transportation Program (STP) provides federal funds to municipalities located in an urbanized area with populations of at least 200,000 and in the MACOG region these funds are available in the South Bend Urbanized Area. Group II STP funds are available to municipalities located in an urbanized area that have populations greater than or equal to 50,000 but less than 200,000. Group II STP funds are available in the Elkhart-Goshen Urbanized Area. Group III STP funds are available to cities and towns located in rural areas with populations greater than or equal to 5,000 but less than 50,000 (Nappanee, Plymouth and Warsaw). Group IV STP funds are available to towns in rural areas that have populations under 5,000, and non-urbanized portions of counties (which include Elkhart, Kosciusko, Marshall and St. Joseph Counties). Overall, the Surface Transportation Programs provided flexible funding that may be used by for projects on any Federal-aid road/highway, bridges and transit capital projects.


Other federal funding sources available included Congestion Mitigation Air Quality (CMAQ), which is an initiative to encourage transportation alternatives that improve air quality in non-attainment and maintenance areas. Within the MACOG region, St. Joseph and Elkhart Counties are considered maintenance areas and therefore are eligible for this funding. Transportation Enhancement (TE) was available statewide to cities, counties, towns, or state agencies for transportation-related activities designed to strengthen the cultural, aesthetic, and environmental aspects of the

Nation's multi-modal transportation system. Safe Routes to School (SRTS) was available statewide to cities, counties, towns, school districts, or state agencies and intended to make walking and bicycling to school safe and routine. Highway Safety Improvement Program (HSIP) and Hazard Elimination & Safety (HES) were available to all counties, cities and towns in Indiana and are used to reduce traffic fatalities and serious injuries on all public roads through the implementation of infrastructure-related highway safety improvements. Bridge funds were available to all counties (including Elkhart, Kosciusko, Marshall, & St. Joseph Counties) for bridge rehabilitations, replacements, and inspections. To be eligible for Bridge funding, a LPA must comply with National Bridge Inspection Standards.


MACOG REGION SUMMARY

The MACOG region obligated a total of \$172.5 million in federal funds from FFY 2004 to FFY 2012, which is approximately \$21.5 million a year. Chart A summarizes the amounts obligated by funding type in the MACOG region. Half of the total federal obligations were from the Surface Transportation Program at \$87.6 million. Other notable funding amounts were CMAQ at \$19.7 million (11%), TE at \$14.7 million (8%) and Bridge funding at \$8.3 million (4%). Additionally the American Reinvestment and Recovery Act (ARRA) funds of 18.8 million were not part of SAFETEA-LU but were obligated during the life of the SEAFETEA-LU bill.

There were a total of 114 projects obligated in the MACOG region in thirteen funding categories, which averages to be approximately 14 projects a year. Chart B on page 5, shows the amount of funds that were obligated during the life of SAFETEA-LU. Local Road Projects received the largest amount of federal obligations, making up and 44% of all obligations or \$67.1 million and 18% of all projects (21). This category includes road maintenance, new road construction, added travel lanes, and surface treatments. The second highest amount of federal obligations was on Bike and Pedestrian projects, making up 16% of all obligations, or \$24.9 million and 27% of all projects. The next highest obligation amount was on Bridge projects received \$8.3 million making up 14% of total



obligation funds and 11% of all projects. Intersection Improvement projects received the fourth highest amount of obligations at \$19.2 million (13%) of all obligations and made up 13% of all projects. Chart C shows the number of each project by project type.





