





## **Next Level Trails**

#### Round 1 closed on February 15

- Up to \$20 million for regional trail projects
- Up to \$5 million for local trail projects

#### 82 applications were submitted statewide

- Over 240 miles of proposed trail
- About \$144 million in requests
- Applications came from 42 counties
- 7 applications from the MACOG region
  - Over 8 miles of proposed trial
  - Over \$4 million in requests

#### Winners are expected to be announced early May
